On behalf of the Outer Banks Chamber of Commerce and its membership, board of directors and volunteers I am writing to urge you to reconsider and oppose the elimination of the pier manager position at Jennette's Pier in Nags Head, NC.

Jennette's Pier is a public, educational and research fishing pier located at Whalebone Junction in Nags Head, North Carolina. The pier attracts visitors year-round; in 2015 over 189,538 people visited the pier and over 750,000 visitors also depend on the pier for access to the beach.

Jennette's Pier is a unique and wonderful combination of public access, and educational and research opportunities. The pier hosts North Carolina school groups who seek to learn more about North Carolina's delicate environmental infrastructure and how to best utilize the resources we have available. In 2015 the pier hosted over 5,770 students who experienced the programs and camps offered at the facility.

Jennette's Pier plays an important role in the local economy attracting people to the area, to the pier and to businesses surrounding its location. Jennette's Pier receives no State appropriations for its operations; it operates solely off the revenue it generates. This past success is attributable to the presence and work of the on-site manager for the pier. The manager of Jennette's Pier oversees not only the daily operations of the pier but is responsible for guiding and facilitating the many successful programs, research and events held there.
